#### ADOPTION OF AGENDA

#### **NEW BUSINESS**

## ACTION NO. 001:

Secretary/Treasurer Borja motioned to approve CLO Report No. 2025-19-003. Member Tenorio seconded the motion. All five (5) members voted in favor, and the motion carried.

## ACTION NO. 002:

Member Tenorio motioned to approve and adopt the School Year 2025-2026 School Meals Menu. Vice-Chairman Anthony Barcinas seconded the motion. All five (5) members voted in favor, and the motion carried.

## ACTION NO. 003:

Member Tenorio motioned to approve the Head Start/Early Head Start Budget Revision Application – Non-Federal Waiver Request and Carryover Request – Reprogram Application. Member Andrew Orsini seconded the motion. All five (5) members voted in favor, and the motion carried.

The BOE called for a break at 11:20 a.m. and returned at 12:10 p.m.

## **EXECUTIVE SESSION**

Member Tenorio motioned to descend into Executive Session. Secretary/Treasurer Borja seconded the motion. All five (5) members voted in favor, and the motion carried. The meeting descended into Executive Session at 12:10 p.m.

Member Orsini motioned to ascend from Executive Session. Member Tenorio seconded the motion. All five (5) members voted in favor, and the motion carried. The meeting returned to plenary session at 3:03 p.m.

Legal Counsel Mocanu stated that the content of Executive Session included discussions on employee grievance statuses, procedures and possible resolutions, the organization of the BOE, the Job Vacancy Announcement (JVA) for Engineer and Legal Counsel positions, and the

coordination between the Full Board and Standing Committees, all of which were appropriate for Executive Session.

## ACTION NO. 004:

Secretary/Treasurer Borja motioned to approve and open a JVA for the Engineer position. Vice-Chairman Barcinas seconded the motion. Four (4) members voted in favor, and one (1) member voted against it. With the majority voting in favor, the motion carried.

The JVA for the Legal Counsel position was tabled due to changes and for further discussion.

#### **MISCELLANEOUS**

Chairman Ogumoro-Uludong stated that all items that were tabled will be brought forward to the next Board meeting. He further stated that all PSS bus routes need to be revisited for the accommodation and safety of students. Chairman Ogumoro-Uludong also recommended that PSS Athletic Director Nicholas Gross have student athletes engage with other students to further inspire and promote the sports community.

Member Orsini motioned to adjourn the meeting. Vice-Chairman Barcinas seconded the motion. All five (5) members voted in favor, and the motion carried. The meeting was adjourned at 3:16 p.m.
