## COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS STATE BOARD OF EDUCATION

### **RESOLUTION NO. 2025-003**

A RESOLUTION OF THE STATE BOARD OF EDUCATION OF THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS DECLARING THE STATE BOARD'S INTENT TO ENTER INTO A PARTNERSHIP CONCERNING CULTURAL AND SCHOLASTIC EXCHANGES FOR THE BENEFIT AND ENRICHMENT OF OUR STUDENTS.

WHEREAS, the State Board of Education ("SBOE") was created by the Commonwealth of the Northern Mariana Islands (CNMI) Constitution to provide maximum educational and training opportunities to the students of the Commonwealth; and

**WHEREAS**, as the SBOE pursues its central objective of developing the human potential of the Commonwealth's students, it is tasked with creating an educational system that allows students to gain the most from their educational experience while preserving their integrity within a global community; and

**WHEREAS**, the SBOE recognizes that meeting the above obligations requires developing partnerships with numerous other entities within and outside the Commonwealth; and

**WHEREAS**, the SBOE recognizes that a well-rounded education requires knowledge of the nations and cultures which are near to the Commonwealth; and

**WHEREAS**, the SBOE recognizes the value of cultural exchanges between students from other countries as opportunities to experience the customs, cultures, and languages of another country are often memorable learning experiences for students and teachers and promote global awareness; and

**WHEREAS**, the SBOE recognizes that the Gyeonggido Office of Education from the Republic of Korea is the office of education for Gyeonggi Province in South Korea. Gyeonggi Province is the most populous province in South Korea, and

WHEREAS, the Gyeonggido Office of Education recognizes the mutual benefits of establishing bonds between our students and educators; and

WHEREAS, the SBOE believes that establishing a sister-school partnership between the schools of the Commonwealth and those administered by the Gyeonggido Office of Education would benefit all participating students, teachers, schools, and their respective communities; and

**NOW, THEREFORE, BE IT RESOLVED**, that the SBOE hereby declares its interest in facilitating a system of academic and cultural exchanges with the schools administered by the Gyeonggido Office of Education; and

**BE IT FURTHER RESOLVED**, that the SBOE instructs the Commissioner of Education (Commissioner) to take all steps necessary to establish such a system of sister-school partnerships and academic exchanges; and

**BE IT FURTHER RESOLVED**, that the Commissioner shall seek and receive the approval of the SBOE before finalizing any such partnership; and

**BE IT FURTHER RESOLVED**, that the Commissioner is instructed to report to the SBOE on his efforts and progress as the need arises, but in no event less than monthly.
