Bids must be placed in a sealed envelope marked "IFB 25-030 Construction of Francisco M Sablan Middle School Building C", containing one (1) original with three (3) copies and submitted to the PSS Procurement & Supply Office, located at PSS Central Headquarters in Capitol Hill Bldg. 1206, no later than July 31, 2025 at 2:30 p.m. at which time, bids will be publicly opened.
