NATURE OF POSITION:

- Instruct and provide care for infants and toddlers (0-3 years of age) in activities designed to promote social, physical, and intellectual growth needed for primary school in preschool, day care center, or other child development facility.
- Contributes to the provision of a quality educational service by assisting and supporting the classroom teachers, instructors, and/or educational specialist with the preparation, enhancement, and administration of learning materials and associated activities.
- Assists with the care and supervision of program clientele (infants and toddlers).
- Reports to the Classroom Teacher or Instructor, or delegate as appropriate. The reporting relationship to teachers may be changed by the Director on a regular basis to fulfill specific needs within the school or care center.

ESSENTIAL TASKS:

These are intended only as illustrations of the various types of work performed. The omission of specific duties does not exclude them from the position if the work is similar, related, or a logical assignment to the position.

- Assists in the supervision of children at all times.
- Assists with home visits.
- Assists in maintaining a safe and healthy environment conducive to learning.
- Assist with the daily maintenance of facility, equipment, and materials.
- Supports children's independence, problem solving skills, initiative, and concentration.
- Assist in curriculum lesson planning, and developing/preparing learning materials.
- Assist with all assessments.
- Conducts observations and inputting of observations into online system.
- Assist with all screenings.
- Assist in maintaining complete and accurate records (family files, reports, assessment reports, outcome reports, etc.), and other related duties, as assigned.

FORTY (40) HOUR WORKWEEK:

The normal work period shall be a seven (7) days work period with a maximum non-overtime of forty (40) hours.

The Public School System (PSS) operates on a 40-hour work week. Actual working hours will be determined on the basis of operational efficiency. School Principals, Supervisors or Program Managers will establish working schedules subject to the approval of the Commissioner of Education.
