DUTIES AND RESPONSIBILITIES:

- Responsible for general ledger accounting including preparation of monthly financial reports.
- Has thorough knowledge of adjusting journal entries and bank reconciliations.
- Reviews bank reconciliation each month of the following account/fund for General Fund, Payroll Fund, Program Activities and Donations, CIP Account, Federal Grants and Employees activities.
- Summarizes and prepares cash position report based on the above reconciliation.
- Participates in the collection, compilation, classification and evaluation of fiscal data.
- Reviews financial reports and make adjustments and entries as needed internally.
- Maintains close liaison with the Finance Director and reconciliation consultant pertaining to the financial statements and other reports necessary for the school and end users.
- Analyzes accounting data and prepares recommendation for the Finance Office review.
- Serves as a liaison between Head Start/Early Head Start Program and Special Education Program and Finance department by assisting program needs related to purchasing, fund status reports, grant reporting and budgeting.
- Coordinates with Federal Program Office and prepare, maintain and reconcile grant reports related to Head Start/Early Head Start Program and Special Education Program.
- Performs other related duties assigned.

JOB RELATED DUTIES AND RESPONSIBILITIES ASSIGNMENTS:

The statements contained herein describe the scope of the responsibility and essential function of this position, but should not be considered to be the only duties and responsibilities of employee(s). Individuals may perform other duties as assigned including work in other areas to cover absences or relief to equalize peak work periods or otherwise balance the workload. Employee(s) may be requested to supervise and/or train the employees. Employee(s) will be required to follow any other job-related duties requested by any person authorized to give instructions or assignments.

FORTY (40) HOUR WORKWEEK:

The normal work period shall be a seven (7) days work period with a maximum non-overtime of forty (40) hours.

The Public School System (PSS) operates on a 40-hour work week. Actual working hours will be determined on the basis of operational efficiency. School Principals, Supervisors or Program Managers will establish working schedules subject to the approval of the Commissioner of Education.

ESSENTIAL FUNCTION OF THE JOB:

The duties and responsibilities listed herein have excluded the functions of the position that are incidental to the performance of fundamental job duties. All duties and responsibilities listed herein are essential job functions and requirements and are subject to modification to reasonably accommodate individuals with disabilities. To perform this job successfully, the incumbent(s) will possess the skills, aptitudes, and abilities to perform each duty proficiently. Some positions may exclude individuals who pose a direct threat or significant risk to the health or safety of themselves or others. The qualification requirements listed in this document are the minimum levels of knowledge, abilities and skills required to perform this position.

MINIMUM QUALIFICATION REQUIREMENTS:

Accountant I – Graduation from a U.S. accredited college or university with a Bachelor’s degree in Accounting, plus one (1) year work related experience OR High School Diploma, plus five (5) years work related experience.

Accountant II – Graduation from a U.S. accredited college or university with a Bachelor’s degree in Accounting, plus two (2) years work related experience OR High School Diploma, plus six (6) years work related experience.

Accountant III – Graduation from a U.S. accredited college or university with a Bachelor’s degree in Accounting, plus three (3) years work related experience OR High School Diploma, plus seven (7) years work related experience.

Accountant IV - Graduation from a U.S. accredited college or university with a BA degree and at least five (5) years related work experience OR High School graduate plus nine (9) years work related experience.

ADDITIONAL QUALIFICATIONS:

Ability to perform multiple tasks. Demonstrate integrity and impartiality. Professional, interpersonal and communication skills. Communicate effectively both orally and in writing, including giving and receiving feedback. Awareness of and sensitivity to cultural issues and local community practices. Ability to work as part of a team.
