### ESSENTIAL TASKS:

These are intended only as illustrations of the various types of work performed. The omission of specific duties does not exclude them from the position if the work is similar, related, or a logical assignment to the position.

- Operates and drives school bus for transporting students to and from school, on approved educational excursion, and other related school activities as assigned.
- Operates and drives the bus with extreme care to ensure the safety and the welfare of bus riding students.
- Escorts students across the street as needed.
- Cleans the bus both interior and exterior, checks tires, oil, fuel, wipers, brakes, stop lights, signal lights and etc. to ensure proper operating conditions.
- Reports needed maintenance and problems to the immediate supervisor.
- Must always follow the traffic safety rules and regulations as well as the bus safety rules and regulations.
- Performs other related duties as assigned.

### FORTY (40) HOUR WORKWEEK:

The normal work period shall be a seven (7) days work period with a maximum non-overtime of forty (40) hours.

The Public School System (PSS) operates on a 40-hour work week. Actual working hours will be determined on the basis of operational efficiency. School Principals, Supervisors or Program Managers will establish working schedules subject to the approval of the Commissioner of Education.

## ESSENTIAL FUNCTION OF THE JOB:

The duties and responsibilities listed herein have excluded the functions of the position that are incidental to the performance of fundamental job duties. All duties and responsibilities listed herein are essential job functions and requirements and are subject to modification to reasonably accommodate individuals with disabilities.
