- Operates and drives school bus for transporting students to and from school, on approved educational excursion, and other related school activities as assigned.

- Cleans the bus both interior and exterior, checks tires, oil, fuel, wipers, brakes, stop lights, signal lights and etc. to ensure proper operating conditions.

# FORTY (40) HOUR WORKWEEK:
